HOW TO MAKE A GIFT TO THE CHRIS O'BRIEN LIFEHOUSE AT RPA

Here are the options for making a gift in your Will:

1. **Percentage of your estate:** It is a good idea to specify a proportion rather than an actual amount as it is very difficult to predict what your estate will be worth or how much you will need for yourself or your dependants in the meantime. The appropriate wording for a percentage gift is:

I give, devise and bequeath _____ percent of my estate free of all duties to Lifehouse at RPA Trust ABN 70 388 962 804 registered office Level 6, Gloucester House, RPA Hospital, Missenden Road, Camperdown, NSW 2050 for its general purposes and declare that the receipt of the Treasurer or other officer shall be sufficient discharge for my executor.

2. **Residual of your estate:** After providing for family and friends and ensuring that all debts have been paid, you can bequeath the remainder of your estate. The appropriate wording is:

After the foregoing provisions of my Will for my family and friends have been carried out, I give, devise and bequeath the rest and residue of my estate remaining, free of all duties for the general purposes of Lifehouse at RPA Trust ABN 70 388 962 804 registered office Level 6, Gloucester House, RPA Hospital, Missenden Road, Camperdown, NSW 2050 for its general purposes and declare that the receipt of the Treasurer or other officer shall be sufficient discharge for my executor.

3. **Percentage of the residue:**

I give, devise and bequeath _____ percent of the residue of my estate free of all duties to Lifehouse at RPA Trust ABN 70 388 962 804 registered office Level 6, Gloucester House, RPA Hospital, Missenden Road, Camperdown, NSW 2050 for The Chris O'Brien Lifehouse at RPA's general purposes and declare that the receipt of the Treasurer or other officer shall be sufficient discharge for my executor.

4. **Specific Bequest:** A gift of a specific sum of money or asset (e.g property, parcel of shares, insurance policy) this should be reviewed periodically to take into account any changes such as a sale of assets. The appropriate wording is:

I give, devise and bequeath _____ free of all duties to Lifehouse at RPA Trust ABN 70 388 962 804 registered office Level 6, Gloucester House, RPA Hospital, Missenden Road, Camperdown NSW 2050 for its general purposes and declare that the receipt of the Treasurer or their officer shall be sufficient discharge for my executor.

5. **Alternative Bequest**: In the event that any of your bequests cannot be carried out, the funds or assets can be assigned to Lifehouse at RPA.
6. **Testamentary Trust**: You can create a testamentary trust to accomplish the long-term fulfillment of your wishes. It can be designed to realize any vision you have of the future and provide ongoing financial support.
